Code: The program is required to refrain from blocking escape routes.

Findings: During the inspection, it was determined the program's alternate escape route had clutter near it which created a safety concern. The clutter fell and blocked the door during inspection. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Low Risk Non-Compliances

Domain: 02 Safe & Sanitary Environment

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.



Findings: During the inspection, it was determined the water temperature was 130 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to have a completed JFS 01234 "Child Enrollment and Health Information for Child Care" on file on the premises for each child.

Findings: In review of the children's records, it was determined the JFS 01234 "Child Enrollment and Health Information For Child Care" was missing the signed date by both the parent and administrator.
