Complaint Allegations

Code: The program staff are not permitted to leave children unattended.

Allegation: A child was left unattended off the program's premises.

Determination: Substantiated

Findings: During the inspection, it was determined that children were not supervised while outside the program as noted in number 3 below:

- 1. Child(ren) left unattended outside the facility building.
- 2. Child(ren) left unattended outside the facility building more than once.
- 3. Child left unattended off the program's premises. A child was able to walk out of the facility building and wander to a nearby laundromat that was located across a main road. An employee at the laundromat notified the police that there was a child unattended wandering around. Staff at the daycare were not aware that the child was missing until local law enforcement contacted the daycare to identify the child.
- 4. Child(ren) left unattended during a swimming activity.
- 5. Child(ren) left unattended in a vehicle.
- 6. Child(ren) left unattended inside the building and no adults were present in the building.
- 7. Other [].

Children must be supervised and within sight and hearing of a child care staff member at all times. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
