Findings: During the inspection, it was determined the provider did not have a completed JFS 01933 "Liability Insurance Statement for Family Child Care Providers" completed for Brooklyn. Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to have a completed JFS 01234 "Child Enrollment and Health Information for Child Care" on file on the premises for each child.

Findings: In review of the children's records, it was determined the JFS 01234 "Child Enrollment and Health Information For Child Care" was not signed by the parent for Tyler Lee.
