Findings: During the inspection, it was determined the following requirements regarding emergency exits and operational conditions were not met by the program: there was no approved second exit on the top floor of the home. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-12 Safe Environment

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.

Findings: During the inspection, it was determined the water temperature was 138 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to post the fire and weather alert plan with a diagram.

Findings: During the inspection, it was determined the fire diagram needed to be updated showing the levels that care takes place.
