Findings: During the inspection, potentially hazardous items or toxic substances were stored where children present had access to it. The following items were found in the home determined to be accessible: 1. Detergent in dining room, 2. Rubbing alcohol under bathroom sink, and 3. Fabuloso cleaner under kitchen sink. All items need made inaccessible to children.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance or item is no longer accessible to children and/or children will not be outside when machinery is in use and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
