- 4. The toilet cleaning brush was accessible to the children.
- 5. The plunger was accessible to the children.

- 8. There was a strong urine odor.

The program must have safety covers on all electrical outlets, including power strips and surge protectors, which are within the reach of the children. - 2. Signature, business address, and telephone number of the licensed physician, physician assistant, advanced practice nurse, certified midwife, or certified nurse practitioner who completed the examination;

- 3. A statement that verifies that the employee is:
- a. Physically fit for employment in a program caring for children;
- b. Immunized against Tetanus, Diphtheria, Pertussis (Tdap);
- c. Immunized against Measles, Mumps, and Rubella (MMR);
- 4. Tuberculosis (TB) screening/test
- a. Documentation of the screening process to determine if the employee resided in a country identified by the World Health Organization as having a high burden of TB and arrived in the United States within the five years preceding the date of application for employment;
- b. Results of a TB test for employees meeting both criteria in 4a;
- c. Results of additional testing for employees with a positive TB test;
- d. Written statement, signed by a representative of the TB control unit, that the employee's TB is no longer infectious or the individual is receiving a TB treatment regimen for employees with a positive TB test.

Submit the program's corrective action plan, which includes a copy of the completed employee medical statement, or TB results/documentation, to the Department to verify compliance with the requirements of this rule.

<u>Code</u>: The program administrator is responsible for the daily operation of the program and maintaining compliance.

<u>Finding</u>: During the inspection, it was determined that the person designated as the administrator was not responsible for the daily operation of the program and for maintaining compliance. It was told to the specialist that the administrator had only been onsite about three times since December. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

<u>Code</u>: The program administrator is required to be onsite at the program for the required amount of time.

the specialist that the administrator had only been onsite about three times since December. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

- 2. No documentation of completing the training after December 31, 2016.
- 3. Completion of the training was not verified in the OPR.
