Code: The program is required to refrain from using and storing potentially hazardous items, toxic substances, and outdoor machinery around children.

Findings: During the inspection, a potentially toxic substance was used where children present had access to it as noted in number 2 below. The potentially hazardous substance posed a risk to children was determined to be accessible to children in kitchen area.

- 1. Bleach.
- 2. Cleaning agent.

Findings: During the inspections, a potentially hazardous substance, which was determined to not present a serious risk to a child, was accessible to children as noted in number 11 below:

- 5. Hand sanitizer (for children under 24 months).

- 1. Telephone cords;
- 2. Stacked chairs;
- Employee(s) purse(s);
- 4. Diaper bags;
- 5. Television not securely anchored;
- 6. Small or lightweight pieces of shelving units are not securely anchored to the wall;
- 7. Staff member stepped over a barrier/gate while holding a child;
- 8. Chipping or peeling paint;
- 9. Other [].

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
