Finding: During the inspection, it was determined that the playground did not have adequate fall surface under and around equipment (red dome climber) as noted in number(s) 1,3 below. Staff stated children have played on the climber:

1. No fall surface
2. Adequate fall surface to soften the impact of a fall
3. Adequate fall surface to soften the impact of a fall that extended the length of the required fall zone

With any equipment designed for climbing, swinging, bouncing, or sliding, resilient material, as specified in Appendix A, needs to be added in order to protect children in the event of a fall.
