Rule: 5101:2-12-20 Cots and Napping

Code: The program is required to provide cots/mats that are the appropriate dimensions for children in care.

Finding: During the inspection, it was determined that all cots and/or mats did not meet the dimensions as noted in number 3 below:

1. The cot must stand at least 3" but no more than 18" off the floor;
2. The cot must be at least 36" in length and as long as the child is tall;
3. The mat must be at least 1" thick and as wide and long as the child assigned.

Code: The program is required to have all surge protectors and outlets covered.

Finding: During the inspection, it was determined that several surge protectors/outlets did not have childproof receptacle covers. The program must have safety covers on all electrical outlets, including power strips and surge protectors, which are within the reach of the children. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is required at this time. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Finding: During the inspection, it was determined that an appropriate germicidal solution was not used to sanitize the diaper changing table, as required by Appendix A of this rule, as noted in number 3 below:

1. The manufacturer's directions were not followed;
2. The solution used was not a commercial product registered by the United States Environmental Protection Agency as a sanitizer;
3. Other: The product used was not appropriate for the surface.
