Gates at the top of stairs shall be wall mounted. Gates shall have no spaces where a child could become entrapped. Accordion style gates shall not be used below:

- 1. Anchored;
- 2. Mounted;
- 3. Free of Entrapment;
- 4. The Approved Style;
- 5. Other [ ].

Although the fence or natural barrier was not meeting the rule requirements, it was determined to not present an immediate risk for a child to be able to leave the playground. The fence or gate was not in good repair and/or being used inappropriately as noted in number(s) [ ] below:
