Domain: 04 Indoor/Outdoor Space

Rule: 5101:2-12-11 Outdoor Play Equipment

Code: The program is required to anchor equipment to the ground as required, to close "S" hooks to prevent the chain from slipping off and prevent strangulation and provide equipment with openings that will not pose a safety risk.

Finding: During the inspection, it was determined that equipment on the outdoor play space posed an imminent risk of harm to a child as noted in number(s) below:

1. The climber was not anchored.
2. The swings were not securely anchored.
3. The slide was not securely anchored.



4. The climbing rope was not securely anchored at both ends.
5. The "S" hooks on the climber were not closed in order to prevent the chain from slipping off the hook and prevent strangulation.
6. The "S" hooks on the swing(s) were not closed in order to prevent the chain from slipping off the hook and prevent strangulation.
7. The older Preschool climber had two openings that were greater than three and one-half inches, but less than nine inches in between ladder rungs. Equipment openings must be less than 3 1/2 inches or more than 9 inches to avoid the risk of entrapment.

Discontinue the use of this equipment until it has been removed, repaired or replaced. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Code: The program is required to provide equipment that does not pose a safety risk.

Finding: During the inspection, it was determined that outdoor play equipment was unsafe as noted in number(s) 1, 5, 10, 11 below:

1. There was rust exposed (pots on fence);
2. There was protruding bolts;
3. There were cracks;
4. There were holes;
5. There was splintering wood (2 wood sheds);
6. There were sharp edges or points;
7. There were lead hazards;
8. There were toxic substances;
9. There were tripping hazards;
10. There was chipped and/or peeling paint (2 red steering wheels);
11. Other: large tires had standing water.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Finding: During the inspection, it was determined that hazardous conditions existed in the outdoor play area, as noted in number(s) 8 below:

1. There was broken glass.
2. There were tall weeds.
3. There was poison ivy.
4. There were tree branches.
5. There was mold visible.
6. There were thistles with prickles.
7. There were bird droppings.
8. There were bolts with more than two threads exposed along a fence line or gate on a playground including some thinly covered bolts that failed the protrusion gauge test (all gate areas).
9. The sandbox was contaminated.
