Findings: In review of the children's records, it was determined the program did not meet the requirements for caring for at least one child, indicated on the Children Records Review, with a condition that requires a JFS 01236 "Child Medical/Physical Care Plan" as noted in number(s) 1 below:

Findings: During the inspection, it was determined that infants younger than twelve months old possibly were able to roll over due to initially placed in a position other than on their back to sleep. The current version of the prescribed JFS 01235 "Sleep Position Waiver for Child Care" form was not on file, as required by this rule. Submit the program's corrective action plan, which includes a copy of the prescribed form signed by both the child's physician and the parent to verify compliance with the requirements of this rule.
