<u>Finding</u>: During the inspection, it was determined that at least one piece of equipment, furnishings, or material at the program was not constructed of materials to facilitate cleaning as noted in number(s) 6 below:

- 1. The material had a tear.
- 2. The material was not washable.
- 3. The material was porous.
- 4. The surface was cracked.

5. The surface was repaired, but in a manner that still did not facilitate cleaning.

6. There is some exposed adhesive strip on the top of a toy shelf in the Young Toddler classroom that is accessible to the children and is not able to be properly cleaned and sanitized.

Equipment, furnishings, and furniture shall be constructed of materials to facilitate cleaning. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is required at this time.
