Code: The program is required to protect children from any items and conditions which threaten their health, safety, and well-being.

Findings: During the inspection, it was determined a lighter was determined to be in reach to children. This was located in the backyard.

Submit the program's corrective action plan, which includes a statement that the item or condition has been removed and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Findings: In review of the staff records, it was determined that a resident of the home turned 18 years of age and background checks were not requested within 10 business days. Rule: 5101:2-13-04 Fire Safety for Type B Homes

Code: The program is required to maintain smoke alarms in the appropriate areas of the program building.

Findings: During the inspection, it was determined that the Type B Home did not have a working smoke alarm on the main level of the home. A working smoke alarm must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. Submit the program's corrective action plan to verify compliance with this rule.

Code: The program is required to properly care for pets and prevent any threat to the safety or health of the children by the pet.

Findings: During the inspection, it was determined the dog needs a Hamilton County dog license and record of vaccinations on file.

Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-12 Safe Environment



Code: The program is required to store cleaning and sanitizing supplies in a place that is inaccessible to children. Cleaning agents, aerosol cans and chemical substances must be stored in their original container or clearly labeled. School-age children may use cleaning supplies and equipment with adult supervision.

Findings: During the inspection, lighter fluid and a septic cleaner were determined to be accessible to children. The lighter fluid was in the backyard and the septic cleaner was under the bathroom sink.

Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance is no longer accessible to children and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

Code: The program is required to have a completed JFS 01234 "Child Enrollment and Health Information for Child Care" on file on the premises for each child.

Findings: In review of the children's records, it was determined the JFS 01234 "Child Enrollment and Health Information For Child Care", was not signed by the parent for Jalea and was missing the fourth page for Na'Vaeh.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
