<u>Code</u>: The program is required to refrain from placing indoor swings, slides, climbers, and climbing apparatus

directly over a hard surface.

<u>Finding</u>: The rule requires that indoor swings, slides, climbers, and climbing apparatus shall not be placed over concrete, tile, carpet, or any similarly hard surface. During the inspection, it was determined that the slide in the toddler room was placed over the carpet. When cleaning or sanitizing supplies are not stored in their original containers, the container must be labeled with the contents.
