Domain: 02 Safe & Sanitary Environment

Rule: 5101:2-12-12 Safe Environment

<u>Code</u>: The program is required to store chemicals and machinery in a place that is inaccessible to children. The program is required to provide an outdoor play area away from machinery in operation.

<u>Finding</u>: During the inspection, a potentially hazardous (dish washer detergent pods) were stored in the kitchenette, adjacent to the Wombat room, under the sink in an unlocked cabinet, where children had access to it, as noted in number(s) 2 below. The door to the kitchenette was propped open from the classroom.

- 1. Bleach.
- 2. Cleaning agent.
- 3. Fish tank chemicals.
- 4. Gasoline.
- 5. Pesticide.
- 6. Poison, including insect/rodent poison.

- 7. Flammable substance.
- 8. Windshield washer fluid.

- 12. Hedge trimmers.
- 13. A snow blower.

Provide staff training. - 4. Staff were not physically present in the space and near enough to respond and reach the child(ren) immediately.
