- 3. Completion of training is not documented with verification from the OPR for the Child Care Staff Member(s) and/or Substitute Child Care Staff Member(s) listed on the Employee Record Chart, as required. Discussion was held regarding an employee with a hire date of 03/03/2023. This employee is within the thirty days of hiring. This employee is not found out of compliance at this time.
