Findings: During the inspection, it was determined that the Type B Home did not have a working carbon monoxide detector in the basement where care is provided. A carbon monoxide detector was not installed in accordance with manufacturer's recommendations. A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. Submit the program's corrective action plan to verify compliance with this rule.

Rule: 5101:2-13-04 Fire Safety for Type B Homes
