Complaint Allegations

Code: The program is required to monitor the number of children in care to remain within the licensed capacity.

Allegation: Nine children in care which exceeds the Type B license capacity.

Determination: Substantiated

Findings: During the inspection, it was determined there were 9 children in care during the hours of operation, which is over the capacity listed on the license. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-20 Crib and Playpen Requirements

Code: The program staff is required to place infants in a crib or playpen to sleep unless a JFS 01235 "Sleep Position Waiver Statement for Child Care" is on file.

Allegation: Infant sleeping in bouncer

Determination: Substantiated

Findings: During the inspection, it was determined an infant slept in equipment other than their crib or playpen and did not have written permission from a physician on file. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
