Rule: 5101:2-12-09 Background Check Requirements

Finding: During the inspection, it was determined that child care staff member(s) would have sole responsibility of children in and neither a preliminary approval nor the JFS 01176 "Program Notification of Background Check Review for Child Care" were on file as required. Code: The program is required to separate children younger and older than 2 1/2 years of age.

Finding: During the inspection, it was determined a group that would include at least one child less than the age of two and one half years of age was not kept separate from a group of older children as noted in number(s) 2 below:

- 1) The [] group, which included children less than two and one half years of age, were cared for in a space where a group of older children were receiving care.
- 2) A barrier was not used to separate the space being used by the group of children less than two and one half years of age from space being used for groups of children two and one half years and older.
- 3) The barrier separating the groups was not at least 36 inches in height.
- 4) The barrier separating the groups was not continuous.

1. Child abuse and neglect recognition and prevention training was not completed within sixty days of hire.
2. First aid training was not completed within ninety days of hire.
3. Cardiopulmonary resuscitation (CPR) training was not completed within ninety days of hire.
4. The child abuse and neglect recognition and prevention training was expired.
5. The first aid training was expired.
6. The CPR training was expired.
7. Other- CPR was not for all age groups served.

30. Other- Pg 32 Modified Diet Policy- Not Addressed, Pg 42 Snack Policy- Not addressed, Pg 24 Preschool Schedule does not include PM snack.

31. Other- Pg 39 Incident Reporting Policy- Policy conflicts with rule. The program must maintain a copy of the incident report. Individuals are not given 24 hours to return the form.

32. Other- Pg 32 Dispensing Medication Policy is not clear. It is unclear what documentation is required for medication and references a doctors note. Additionally, there must be a trained staff member caring for the child at all times. The program policy states an individual must be onsite.

33. Other- Pg 48 The last paragraph is unclear. Please review and revise as necessary.

Revise the program's written policies and procedures to include the missing information. Submit the program's corrective action plan, which includes the revised written policies and procedures, to the Department to verify compliance with the requirements of this rule.
