Domain: 04 Indoor/Outdoor Space

Rule: 5101:2-12-11 Outdoor Space Requirements

<u>Code</u>: The program is required to have an outdoor play space free from immediate risk.

<u>Finding</u>: During the inspection, it was determined that an area was used which was not protected from traffic. Although the school is regulated by another agency and therefore a fence or other barrier is not required, the program must ensure the safety of children at all times. A large bucket lift truck was observed driving on the driveway which circles around the playground and cars were also observed using the driveway while children were playing on the blacktopped area in the driveway. It was determined that this situation presented an immediate risk for children.

Provide a safe space for outdoor play which is protected from hazards. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

<u>Code</u>: The program is required to have a completed JFS 01236 "Child Medical/Physical Care Plan for Child Care" on file at the program for any child having a health condition and must implement and/or follow instructions on the plan. <u>Finding</u>: In review of the children's records, it was determined the program did not meet the requirements for caring for at least one child, indicated on the Children Records Review, with a condition that requires a JFS 01236 "Child Medical/Physical Care Plan" as noted in number 38 below:
