Complaint Allegations

Allegation: It was alleged that the program was not providing a safe environment as required by rule.

Determination: Substantiated

Findings: The allegation is substantiated in that, during the inspection, it was determined that a potentially hazardous item or toxic substance was used or stored in an unlocked laundry room and an unlocked storage room where children had access to it, as noted in number(s) 2 and 14 below.

1. Bleach.
2. Cleaning agent (disinfectants)
3. Fish tank chemicals.
4. Gasoline.
5. Pesticide.
6. Poison, including insect/rodent poison.
7. Flammable substance.
8. Windshield washer fluid.
9. Aerosol cans.
10. A lawn mower.
11. A weed trimmer.
12. Hedge trimmers.
13. A snow blower.
14. Other potentially hazardous substance, equipment or machinery: paint cans.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance or item is no longer accessible to children and/or children will not be outside when machinery is in use and a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
