Allegation: Allegedly cleaning solution (Bleach water) was stored within children reach and was spilled on a child.

Determination: Substantiated

Findings: During the inspection, a potentially hazardous item or toxic substance was used and stored on a desk in middle of the pre-k room where children had access to it, as noted in number 1 below.

1. Bleach - (small bucket with bleach solution)
2. Cleaning agent.
3. Fish tank chemicals.
4. Gasoline.
5. Pesticide.
6. Poison, including insect/rodent poison.
7. Flammable substance.
8. Windshield washer fluid.
9. Aerosol cans.
10. A lawn mower.
11. A weed trimmer.
12. Hedge trimmers.
13. A snow blower.
14. Other potentially hazardous substance, equipment or machinery: [].

Provide staff training.
