Rule: 5101:2-12-20 Cribs

Finding: During the inspection, it was determined the [mattress support was not maintained at the lowest position for the white cribs when in use, as required. Except when infants are being placed in cribs, removed from cribs, or being soothed, the sides should remain in the highest position. Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is required at this time and forward photo documentation to specialist to show cribs in lowest position.
