Findings: During the inspection, it was determined 8 children with 3 under two years of age were in the care of one child care staff member which resulted in more than six children/three children under two years of age. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5180:2-13-13 Handwashing

Code: The program staff and residents are required to wash their hands at the appropriate times as outlined in rule.

Findings: During the inspection, it was determined the handwashing requirements were not being followed by the provider, program staff, residents, or a child in that after diaper change for provider or child. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5180:2-13-22 Food Handling

Code: The program is required to refrain from serving food on bare tables.

Findings: During the inspection, it was determined that food was served directly on bare tables. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Domain: 07 Diapering & Infant Care

Rule: 5180:2-13-20 Crib and Playpen Requirements

Code: The program is required to use a crib/playpen according to manufacturer's guidelines.

Findings: During the inspection, it was determined that a crib/playpen was not being used according to manufacturer's instructions as the mattress was not attached to the playpen. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
