Rule: 5101:2-13-12 Safe Environment



Code: The program is required to store cleaning and sanitizing supplies in a place that is inaccessible to children. Findings: During the inspection, cleaning and sanitzing equipment and supplies were not used or stored properly as noted in number 14 below:
