Code: The program is required to have an outdoor play space free from immediate risk.



Findings: During the inspection, it was determined that an outdoor play area was used which was not protected from traffic and other hazards by a fence in good repair, or other barrier. Although the fence or natural barrier was not meeting the rule requirements, it was determined to not present an immediate risk for a child to be able to leave the playground. The fence or gate was not in good repair and/or being used inappropriately as noted in number(s) 1,2,4,11 below:

1. The fencing had missing slat boards.
 2. The fencing was broken.

Code: The program staff is required to protect the children from hazardous conditions in the outdoor play area.

Findings: During the inspection, it was determined that the following hazardous conditions existed in the outdoor play area, as noted in number 1 below:

1. There was broken glass.

Code: The program is required to place equipment away from main traffic patterns that would create unsafe conditions.

Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well-being. During the inspection, it was determined that at least one area of the program or at least one piece of equipment had chipping or peeling paint. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Code: The program is required to provide equipment that does not pose a safety risk and must follow the manufacturer's guidelines for assembling, installing and using the equipment.

Findings: During the inspection, it was determined that outdoor play equipment was unsafe as noted in the number(s) 1, 2, 3, 5, 6 below:

1. There was rust exposed.
2. There was protruding bolts.
3. There were cracks.

5. There was splintering wood.
6. There were sharp edges or points.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
