Findings: During the inspection, it was determined that the Type B Home did not have a working carbon monoxide detector in the building nor on each floor where care is provided in accordance with manufacturer's recommendations. A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations.
