Findings: During the inspection, it was determined that the provider provided false information, in that provider submitted documentation in OCLQS from an inspection on 11/6/25 that appeared to be altered by someone other than the individual who originally signed the document. Rule 5180:2-13-03 requires the program to notify parents when a serious risk non-compliance is cited. The notification must inform parents of the serious risk non-compliance and include the Department of Children and Youth website and location of further information regarding the determination. Submit the program's corrective action plan to verify compliance with the requirements of this rule.
