Findings: During the inspection, it was determined the water temperature was 132 degrees in the following room: first floor bathroom. This temperature exceeds the requirement of remaining below 120 degrees

2. The posted menu was not in a visible place readily accessible to parents.
3. The menu was not currently dated.
4. The entire menu was substituted.
5. At least one item on menu did not match what was served.
6. The meal or snack served did not match the posted menu.
