Findings: During the inspection, it was determined the program did not meet the requirements for keeping an attendance record as listed in number(s) 2, 3, 4, 6 below:

1. No attendance record was being maintained.
2. The attendance record was not being consistently completed in that 4 of 6 children were signed-in on the record.
3. The record did not include the last name of at least one child.
4. The record did not include the birth date of at least one child.
5. The record did not include the assigned group.
6. The record did not include the child's weekly schedule.
7. The record did not include the time (hours and minutes) of each child's arrival and departure to the program, including transportation by the program.
8. The original attendance record was not kept at the program for a period of one year.

Attendance records were previously noncompliant on the following inspection dates: 9/5/24, 1/2/25, 4/23/25. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
