Complaint Allegations

If a program disagrees with a licensing finding, the program may request a review of the finding(s). Code: The program is required to have firearms and ammunition out of sight.

Allegation: Complaints were received by phone from two caretakers from separate families whose children were in attendance at the same time during the alleged incident. Both caretakers reported that their children told them that the provider's husband Jordan Nelson who is also a CCSM (unclear if he was working at the time as a CCSM or acting as a resident in the home) showed the children knives and a sword that he had made. One caretaker then stated that the children told her that he stated that "kids get cut in half" in relation to their behavior at the time. The other caretaker reported the children told the caretaker that he stated "you will get cut" if you don't behave. One caretaker provided text messages from the provider and a picture of some of the weapons that he prints on a 3D printer. Both caretakers stated that this happened on February 26th during evening care. Per their reports those present during this incident was the provider Anna Nelson and her husband Jordan Nelson and the children in care. This information was not reported to any other agencies or law enforcement. The caretakers reported that children were not shown weapons or knives or swords after this one incident.

Allegation concerns rule 5180:2-13-12 B Safe Equipment and Environment which requires that "Weapons, firearms and ammunition materials shall be kept inaccessible to children, out of sight of children and in locked storage areas. Weapons and firearms include air rifles, hunting slingshots and any other projectile weapon."

Determination: Substantiated

Findings: During the inspection, it was determined there were knives and an arrow head (unable to determine if a sword was present) on the premises of the program that were secured, but visible to children on the date that the incident happened based on text messages and a picture from the provider sent to caretakers and from the providers statement that this occurred.. Weapons, firearms, and ammunition must not be visible to children. Provider did indicate during the inspection that this will not happen again and that any items that could be considered weapons made in the home will not be visible to children and will continue to be secured.

Submit the program's corrective action plan, which includes a statement that the homemade/3D printed knives, arrow heads, swords, etc. are no longer visible to children to verify compliance with the requirements of this rule.
