Code: The program is required to have the mattress support in the lowest position and crib rails in the highest position in all cribs.

Finding: During the inspection, it was determined the mattress was not maintained at the lowest position for all cribs when in use (as a lulla vibe was placed under the mattress), as required. Except when infants are being placed in cribs, removed from cribs, or being soothed, the sides should remain in the highest position.
