- 6. There was not a fall zone of 6 feet in all directions from the perimeter of the equipment (Metal Climber and Toy House)
- 8. The fall zone was less than 9 feet from each piece of applicable equipment. (Kidtime Mermaid Climber and Spring riding squirrel)
- 9. Other-.Ground bound head entrapment under Kidtime mermaid climber and metal climber stairs
