## **Complaint Allegations**

If a program disagrees with a licensing finding, the program may request a review of the finding(s). Ohio Administrative Code 5101:2-12-03 and 5101:2-13-03 detail the process for submitting a request for review. The request for review must be submitted within seven business days from the receipt of the licensing report. In addition, if the program is star rated, the rating may be impacted if a serious or moderate risk non-compliance is cited.

## Domain:01 Ratio & Supervision

Rule: 5180:2-12-19 Child Guidance

Code: The program staff shall use developmentally appropriate techniques when managing children's behavior and shall not abuse, endanger or neglect children.

Allegation: Staff did not protect a child from another child's behavior.

Determination: Substantiated

Findings: During the inspection, it was determined that a child-care staff member had neglected a child. It was determined that staff failed to provide adequate supervision of children in their care. This conclusion is based on an incident in which one child sustained a scratch caused by another child while attending the program. Staff were unable to confirm the duration of the altercation between the two children, indicating a lapse in active supervision at the time of the incident. Child care staff members, administrators, and owners must always use appropriate guidance and management methods with children and ensure that children are safe at all times.

Rule 5180:2-12-03 requires the program to notify parents when a serious risk non-compliance is cited. The notification must inform parents of the serious risk non-compliance and include the Department of Children and Youth website and location of further information regarding the determination. Submit the program's corrective action plan, which includes a statement that staff have been properly trained on this rule and a copy of the written parent notification, to the Department to verify compliance with the requirements of this rule.
