Rule: 5180:2-12-13 Toothbrushing Requirements

Code: The program is required to have a sanitary system for tooth brushing.

<u>Finding</u>: During the inspection, it was determined that the program's procedure for brushing teeth was not sanitary, as noted in numbers 1,2 below, as required.

- 1. The toothbrushes were not labeled.
- 2. The toothbrushes were not stored with bristles to air dry in a manner to prevent contact with other toothbrushes or surfaces.
- 3. The toothpaste from a common tube was not dispensed on individual clean pieces of paper or a paper product for each child.

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
