Findings: During the inspection, it was determined that program staff did not cooperate with the inspection or complaint investigation, as required, in that the provider did not allow HCJFS staff access to a room in the home. Provider stated the door was locked, she did not have the key and could not gain access to the key to allow HCJFS staff to verify the room did not contain any items that would prevent the program from ensuring the health, safety and well being of the children in care. Findings: In review of the staff records, it was determined that child care staff member(s) or substitute child care staff member(s) did not meet the requirements for completing the online orientation training as noted in number 1 below:

1. The training was not completed within 30 days of starting employment at the program as a child care staff member.
2. No documentation of completing the training after December 31, 2016.
3. Completion of the training was not verified in the OPR.
4. A child care staff member had sole responsibility of children and had not completed the online orientation.

Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
