Finding: During the inspection, it was determined that the placement of cots or mats in the toddler nap room did not meet the requirements as noted in number(s) 1 below:

1. The placement did not allow for a clear pathway to each cot.
2. Cots or mats blocked exits.

Rule: 5180:2-12-12 Safe Environment
